

## MINNEHAHA LODGE #165 SCHOLARSHIP

Minnehaha Masonic Lodge #165 A. F. & A. M., with matching funds from Minnesota Masonic Charities will present each year one (1) \$2000.00 scholarship. The scholarship can be renewed on an annual basis, provided the recipient reapplies and meets the qualifications and approval of the scholarship committee each year of eligibility, for a total of 4 years and \$8000 maximum.

To be eligible to receive a scholarship from Minnehaha Lodge #165, an applicant must be a child, grandchild, nephew, niece, grand nephew, grand niece or dependent (IRS definition) of a member of Minnehaha Lodge #165 in good standing (or who was in good standing at the time of his death), or a present or former member in good standing of International Order Job's Daughters or a Chapter of DeMolay. The applicant must have an academic ability and qualifications to allow them to satisfactorily complete the course applied for and demonstrate financial need.

The person receiving the award must be completing their last year of high school or be of post high school age.

The Scholarship can be applied towards costs of either a vocational-Technical school or a college of the student's choice.

The date the applications are to be to the chairman of the Lodge Scholarship Committee shall be no later than **May 1**, of the current school year.

The award will be made payable to both the student and the school of their choice made payable by August 15 of the year.
